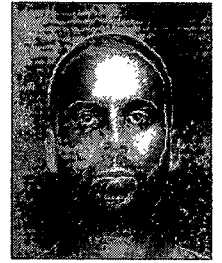

On Saturday, January 1, 2022 at approximately 4:51 AM, Broward Sheriff's Office (BSO) deputies responded to the intersection of W. Atlantic Boulevard and Powerline Road, in the City of Pompano Beach, Broward County, Florida in reference to a vehicle versus vehicle traffic crash.

Probable Cause Affidavit

Before me this date personally appeared PORTORO, SHERRY L. (11631) who being first duly sworn deposes and says that on 1 day of January, (year) 2022 at 2580 W ATLANTIC BLVD/N POWERLINE RD, POMPANO BEACH, FL 33069 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

surveillance obtained, and all other available information, the following was determined: Prior to the crash, the Ford Explorer, which is a marked patrol unit for the City of Margate, was being driven by the VICTIM. The VICTIM was traveling westbound, in the center thru lane, on W. Atlantic Boulevard slowing to a stop for the red light at Powerline Road.

The Mercedes GLE400 being driven by the SUSPECT was also traveling westbound on W. Atlantic Boulevard in the center thru lane. The SUSPECT, who was traveling at an excessively high rate of speed, was approaching the red light at the intersection of Powerline Road.

An independent WITNESS reported she was traveling westbound on W. Atlantic Boulevard approaching Powerline Road when she was passed by the speeding Mercedes. The WITNESS stated she saw the marked patrol unit (Ford) was stopped for the traffic light when the impact occurred.

While the Ford was slowing to a stop for the red traffic light, the Mercedes came from behind and struck the rear of the Ford. The impact caused the Ford to be projected forward in a southwesterly direction causing it to come to final rest within the middle of the intersection facing a northwesterly direction.

Post impact, the Mercedes continued in a northwesterly direction in an arcing pattern. The Mercedes traveled into the southbound lanes of Powerline Road, over the raised concrete median where it proceeded eastbound across the northbound lanes of Powerline Road. The Mercedes came to final rest facing west with the rear wheels on the sidewalk

Probable Cause Affidavit

Before me this date personally appeared **PORTORO, SHERRY L. (11631)** who being first duly sworn deposes and says that on **1** day of **January**, (year) **2022** at **2580 W ATLANTIC BLVD/N POWERLINE RD, POMPANO BEACH, FL 33069** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
and the front wheels in the northbound lanes of Powerline Road.

Deputy Wells arrived on scene and made contact with the SUSPECT who was seated in the driver's seat of the Mercedes with his seatbelt on. The SUSPECT was the sole occupant of the Mercedes. Deputy Wells reported as she interacted with the SUSPECT, she detected signs of impairment to include an odor of an alcoholic beverage emitting from his breath and red / bloodshot eyes.

The VICTIM was transported by Fire / Rescue to Broward Health North Medical Center to be treated for injuries including but not limited to a broken ulna and the radial in her left forearm which was described as "shattered". The VICTIM was admitted to the hospital and required surgery to repair the injuries sustained from the crash.

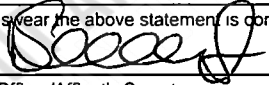
The SUPSECT was transported by Fire / Rescue to Broward Health North Medical Center where hospital personnel drew medical blood. The medical blood was later obtained via a search warrant and forwarded for analysis.

DUI Deputy Popick responded to the hospital and completed an independent DUI investigation. DUI Deputy Popick a obtained voluntary blood sample from the SUSPECT which was also forwarded for analysis.

On Friday, January 28, 2022, I received the toxicology report for the SUSPECT's blood sample 'A' (01/01/22 05:24) which was analyzed by the Forensic Toxicology Laboratory, Department of Pathology at the University of Miami, Miller School of Medicine. The toxicology results indicated the SUSPECT tested positive for Ethanol at a concentration

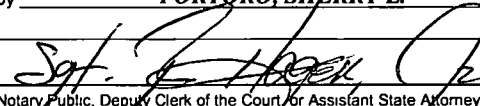
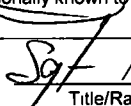

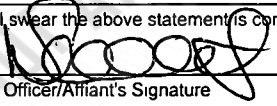
Probable Cause Affidavit

Before me this date personally appeared **PORTORO, SHERRY L. (11631)** who being first duly sworn deposes and says that on **1** day of **January**, (year) **2022** at **2580 W ATLANTIC BLVD/N POWERLINE RD, POMPANO BEACH, FL 33069** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:
of 0.149 g/100 mL, indicating he was impaired at the time of the traffic crash.

Based upon accepted mathematical formulas, the damage to the vehicles, and the Event Data Recorder (EDR) imaging of the Mercedes, it was determined the Mercedes was traveling in excess of eighty (80) miles per hour, which is in excess of the forty-five (45) miles per hour posted speed limit. This speed range is consistent with the post-crash distances traveled and the damage sustained is consistent with each vehicle.

Based on the information, probable cause exists to believe that the SUPSECT did then and there drive the Mercedes with a willful or wanton disregard for the safety of persons and / or property. The SUSPECT also unlawfully drove a vehicle while under the influence of an alcoholic beverage to the extent his normal faculties were impaired, causing a traffic crash to occur. The crash directly resulted in serious bodily injury to the VICTIM, property damage to the Mercedes, and property damage to the Ford Explorer owned by the City of Margate.

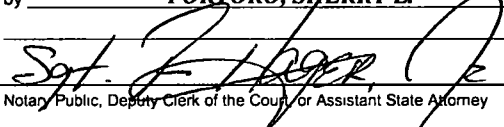

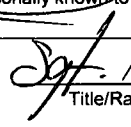
