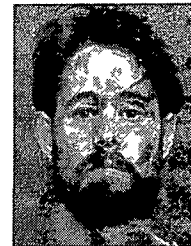

Probable Cause Affidavit

Before me this date personally appeared JACKSON, KARL (19685) who being first duly sworn deposes and says that on 20 day of September, (year) 2021 at 126 NW 8TH AV, DANIA BEACH, FL 33004 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

to wash his hands Sarduy further stated that he works in the construction field and flies out of town every other week to Michigan for work, and that he advised his wife not to answer the door for anyone

Sarduy advised that when answered the door he got upset and confronted her about it, I asked Sarduy why was crying and he advised that she was crying because he was talking on the phone to his mom and she got emotional

I then spoke with who was very emotional and red faced with tears running down her face who advised that there was only a verbal altercation between her and Sarduy I asked to explain to me why she was in tears and she advised that Sarduy was upset with her because she responded to the knock on the door from the maintenance man who asked her for soap and she went and got the soap I asked to explain exactly how it all happened, stated that she was standing in the kitchen when Sarduy came and asked her to come outside and that when she got to living room, he held her by her left upper arm on the bicep area and lead her outside and asked her what was going on between her and the maintenance man hinting that she might be cheating

I then asked if that was all that transpired to which she responded yes However, seemed to be very emotional and in fear as she explained the events, as demonstrated to me how Sarduy lead her out of the house, I observed a bright red abrasion on the right side of her neck, I asked how she got scratch to which she advised that she always scratches herself was concern about Sarduy as she asked if he was going to jail, as she remained emotional and had a look of surprise on her face

Probable Cause Affidavit

Before me this date personally appeared JACKSON, KARL (19685) who being first duly sworn deposes and says that on 20 day of September (year) 2021 at 126 NW 8TH AV, DANIA BEACH, FL 33004 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

After which I spoke with [REDACTED] the complainant, who advised that he was about to go on break from working, so he knocked on [REDACTED] door and asked for soap to wash his hands [REDACTED] further stated that Sarduy then came to the door being very irate and shouting at him that he should move from his door and shoved [REDACTED] in the chest area aggressively with both hands and then went and got what appeared to be a black handle kitchen knife and stood by the door with by his side but he could not see the blade of the knife, and that he was not in fear [REDACTED] added that while he was not in fear, he was fearful that Sarduy would harm [REDACTED]

[REDACTED] was asked to give a statement in to the entire incident, to which refused [REDACTED] was given a brochure with the number for women in distress and was also told of her rights according Marsy's Law

[REDACTED] gave a recorded statement about what he observed but advised that he did not want to press charges against Sarduy because he was not in fear

Therefore, there was not enough evidence or probable cause, to charge Sarduy for his actions in relation to his altercation with [REDACTED], because there was no fear that he would do harm to [REDACTED]

Let it be known that [REDACTED] and Sarduy are living together as a family in the same household and have three children in common

Sarduy was arrested and charged for Domestic Battery
