The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/05/2022, at approximately 1921 hours, deputies responded to 265 Van Gogh Cir, Brandon, FL 33511, in reference to a domestic violence dispute. Upon arrival, it was determined that a verbal altercation turned physical between the defendant and victim, which turned physical when the defendant armed herself with a metal Yeti cup and attempted to strike the victim, but missed. The defendant then armed herself with a half-full gatorade bottle and struck the victim in the back of the head. The battery continued when the defendant poured wine on the back of the victim head, back and neck. The battery was intentional and against the victim's will. The defendant and victim are currently married and reside together with children they each have from a previous marriage. The victim positively identified the defendant as the person who committed the offense. The victim verbally identified herself, which I confirmed VIA an RMS photograph.
