Officers arrived on scene and saw a W/M fitting the above description sitting on the curb near a black truck. Officers detained the W/M and no weapons were located on his person. The W/M was later identified by his FLDL, he will be referred to as V1. Officers went to meet the alleged victim, Betancourt outside the apartment complex.

Betancourt told me the following: She has known V1 for approximately a week and have been in an intimate relationship. On 08/11/2022 V1 and Betancourt went on a date and when they came back to 6720 Congress Ave they got into an argument. Betancourt advised as she was getting out of the vehicle, V1 took her belongings (cellphone and keys) from the cupholder. Betancourt began to ask for the items back and V1 stated no because he wanted to talk. V1 threw her keys within the vehicle and Betancourt asked for her phone. She stated V1 began to drive off, with her inside the vehicle, inside the parking lot. Betancourt stated VI began to drive away, and she pulled out her firearm from her purse. Betancourt stated they 'struggled' for the firearm and V1 eventually took possession of the firearm from the struggle. Betancourt held her hand up to her throat stating V1 pointed the gun at her face and stated "You wanna see what I was like". He then stopped the vehicle, she jumped out and ran to her neighbor's door. It should be noted that Betancourt originally told me she pointed her firearm at V1 because she wanted to obtain her property back and not in self-defense. When I started to ask more in-depth questions, she changed her response to self-defense. I asked again why she pulled out her firearm and she stated, "because I thought he was going to fucking hit me." I asked her why she thought he was going to hit her and she stated, "because he was yelling at me and told me he wasn't going to give me my shit back and it wasn't okay to walk out on an argument." She then stated, "I didn't know what else to do, I couldn't leave he had all my shit." When I asked her for her side of the incident again, she changed her response to VI held the door as he drove off with the phone in one hand and him holding the door in the other. Betancourt had injuries to the webbing of her left hand (near her thumb) which are consistent with someone racking the slide of a firearm. She did not tell officers she racked the slide of the firearm until later in the investigation when asked.

I spoke to VI who told me the following: They have been in an intimate relationship for approximately 8 days and have seen each other everyday since. Tonight, they went out and when they came back to her residence, they had an argument in the parking lot. While in the parking lot she was getting out of the vehicle, and he grabbed her cellphone from the cupholder. VI stated she 'freaked out' and pulled her firearm out of her purse. She 'racked' the slide and pointed it at his head. While the firearm was pointed at his head she demanded for her phone. VI said at this point, the phone was dropped somewhere inside the vehicle. VI stated he was in fear for his life and grabbed the firearm out of her hands. Betancourt then jumped out of the vehicle and ran to the apartment building. He tried to tell an unknown male to take her property to her but refused. The unknown male in the parking lot was never discovered. VI then went to her apartment (208) and placed her belongings under her doormat. When I asked VI about Betancourt alleging him putting the firearm up to her face he stated he did not do that. He also advised he never held the door closed so she could not get out of the vehicle.

Based on the investigation conducted, there were conflicting statements with no independent witnesses; however, it was determined that the temporary taking of the phone in an attempt to keep Betancourt within the vehicle, did not constitute a response of aggravated assault with a deadly weapon. Therefore, probable cause was established to charge Betancourt with Aggravated Assault with a Deadly Weapon pursuant to F.S.S. 784.021(1A).
