The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a blue Nissan 4D bearing FL tag 33BNTL. The defendant was observed stopped past the stop bar with the vehicle obstructing the marked crosswalk. As it travelled north on Howard Av N, it weaved in its lane causing the passenger side tires to cross the lane line several times, and at one point affecting a vehicle traveling in the outside lane causing it to slow down and honk the horn. Upon contact, the defendant exhibited indicators of impairment to include bloodshot and glassy eyes, slurred speech, the odor of an alcoholic beverage emanating from her breath, disheveled clothing, admission of drinking and unsteadiness on her feet. The defendant participated in SFSE's, which showed further indicators of impairment, and was subsequently arrested for DUI. Upon search of the vehicle, an opened half full can of "Four Loko" alcoholic beverage was located in the center console.

The defendant provided breath samples of .207/ .186/ .217.

The defendant was ID'ed via FL DL.
