Affiant observed the defendant to have red watery eyes, slurred speech, poor fine motor skills, and strong odor of alcoholic beverage on his breath. The defendant performed poorly on standardized field sobriety exercises indicating impairment. Subsequent to arrest, the defendant was transported to central breath testing where he refused to submit to breath testing after being read implied consent.
