The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a white 2018 Mercedes SUV bearing a Texas license plate of NXL3531. She was traveling west on Brorein St at Tampa St and caused a traffic crash when she failed to stop for a red light and struck a pedestrian and a vehicle. This caused leg and back injuries to the victim as he was pinned between the defendant's vehicle and his vehicle. The victim was standing outside of his vehicle, in the intersection, because moments earlier he was involved in a traffic crash. The defendant failed to see the two vehicles, and victim, in the intersection. The defendant was positively identified as the driver at the time of the crash. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, very slurred speech, slow and sluggish movements, difficulties concentrating, a strong odor of an alcoholic beverage on her breath, extremely unsteady stance, and an unsteady walk. The defendant performed extremely poorly on SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning. The defendant was identified by her FL DL.
