The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a white Ford van bearing FL tag 81AYNN. While stopped at the traffic signal at Howard Av / Kennedy Bv, he flagged me down to talk to me through the window. As I rolled the window down to speak with him, he began singing loudly at me. I noticed that his eyes were droopy and his speech was slurred. His passenger advised him to stop and he then approached the vehicle in front of me and honked his horn multiple times for no apparent reason. As we continued northbound on Howard Av, I observed the vehicle weave in its lane causing the tires to ride along the lane dividing line. He stopped improperly at the signal at Howard Av / Cypress St. I activated my emergency lights and he had a very delayed response to the stimulus. Upon contact, he exhibited indicators of impairment to include bloodshot droopy eyes, slurred speech, the odor of an alcoholic beverage emanating from his breath, and unsteadiness on his feet. He stated he was coming from "the bars" but denied drinking. He participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI.

The defendant provided breath samples of .168/.158.

The defendant was ID"ed via Israeli DL.
