The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above date and time I observed a 2010 silver Hyundai sedan bearing FI-tag LGML58 (VIN:KM8JT3AC9AU078160) traveling southbound and breaking the both inner and outer solid lane markers multiple times. I conducted a traffic stop at the above location. I made contact with the defendant who was the sole driver and occupant of the vehicle. Upon contact I detected signs of impairment. I requested the defendant to exit the vehicle and participate in field sobriety exercises which she refused to do. Due to the observed driving pattern, indicators of impairment and the totality of the circumstances the defendant was placed under arrest for DUI. The defendant was transported to CBT and Post implied consent the defendant agreed to provide a lawful breath sample. After a proper 20 minute observation the defendant provided a BrAC of .138/.126. The defendants identity was verified via US Passport.
