The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a 2016 red Honda Civic bearing a Florida license plate of HPU0S. She was traveling west on Kennedy Blvd between Armenia and Glen and was weaving back and forth, unable to maintain a single lane. There was another vehicle in the lane next to the defendant that could not pass because the defendant's vehicle was straddling the lane divider and was in both lanes. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a drunk-like appearance, slow and sluggish movements, and a strong odor of an alcoholic beverage. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .173 and .170.

The defendant was identified by her FL DL.
