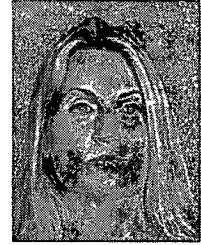

Before me this date personally appeared WILSON, BRANDON M (19248) who being first duly sworn deposes and says that on 18 day of March (year) 2022 at 700 W HILLSBORO BLVD, DEERFIELD BEACH, FL 33441 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

approximately 2355 hours he observed a Silver Infiniti bearing FL Tag ISJC46 traveling westbound near the 100 block of W Hillsboro Blvd The Infiniti weaved in and out of its lane keeping Deputy Moreira and other motorists from safely passing it Deputy Moreira activated his emergency lights and attempted to conduct a traffic stop at approximately the 300 block of W Hillsboro Blvd as he was concerned for the health and welfare of the driver, but the Infiniti continued traveling westbound, failing to come to a stop until a Florida Highway State Trooper that was passing by pulled his marked unit in front of the Infiniti and braked until the vehicle came to a stop The State Trooper then left the area

During contact, Deputy Moreira observed the driver, later identified as Natasza Pludowski per her Florida Driver's License, to be confused, have slurred speech and glossy eyes When asked to provide her driver's license, Pludowski fumbled all over the car attempting to locate the license although it was located in her wallet which was inside of the purse that was sitting on her lap Pludowski also could not find her car keys which were also located in the same bag

I arrived on scene and made contact with Pludowski who was still seated in the driver's seat of her vehicle I requested that she exit the vehicle and step to the rear of her car When she exited the vehicle she held onto the door and roof of the car for balance Pludowski was unsteady on her feet and had difficulty walking straight I observed glossy eyes, slurred speech and a very strong odor of alcohol emanating from her breath during conversation

Before me this date personally appeared WILSON, BRANDON M (19248) who being first duly sworn deposes and says that on 18 day of March, (year) 2022 at 700 W HILLSBORO BLVD, DEERFIELD BEACH, FL 33441 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

begin the exercise prior to being instructed to begin She had difficulty getting into the starting position and failed to listen to any of the remaining instructions She did not complete the exercise

One Leg Stand Pludowski refused to listen to any instructions given and did not complete the exercise

Based on the totality of the circumstances, I made the determination that Pludowski was under the influence of alcohol and/or a chemical substance, and/or a controlled substance to the point that her normal faculties were impaired As a result, I informed the defendant she was under arrest for DUI I then requested a breath test, at which time she refused I then read the defendant the Florida Implied Consent Law (0021 hours) and she still refused Time of refusal (0022 hours)

Deputy Moreira completed a DUI supplement report

A teletype/DAVID check revealed that Pludowski has a previous conviction for DUI on 07/12/2005

The defendant was subsequently transported to the Broward Main Jail
