On 05/24/2022 Deputies were dispatched to 5388 Riverstone Way in the city of Westlake Florida in reference to a battery that had just occurred. Deputies spoke with Jennifer Montes De Oca DOB 04/08/1984. Jennifer met with deputies down the street away from the residence she stated this incident occurred.

Jennifer stated the following not verbatim. She was going door to door advertising for a company she works for. The company is Aquakleen Water Refinement Systems. She said she walked up to the front door of 5388 Riverstone Way and a male answered the door. She told him what her purpose was being there and asked if he was interested in hearing about the company and he said no. She said she then started to walk away and the male came outside and started yelling at her demanding to know what company she works for. Jennifer showed him her ID which was attached to a lanyard around her neck with her name, picture and company name on it. Jennifer said that the male grabbed her ID which was still attached to her neck and yanked it off the lanyard. This action she said caused her head to go forward and down with force since he was ripping the ID off her neck. Jennifer said the ID was ripped off her neck and he took it. She said her neck was sore that is how hard he grabbed it. She said she told him she was calling the police and walked away from him since he was being so belligerent and aggressive. Before Deputies arrived she said the male got in a black truck and drove away.

While Deputies were speaking with Jennifer the male drove by and Jennifer said that was the person that grabbed her iD that was now missing. Deputies got behind the truck and stopped it at the corner of Sea Glass Way at Quiet Lake Place still within the complex of Skycove. Deputies then spoke with the driver who was identified by his Illinois DL as Nicacio Dasivia DOB 03/29/1970. Nicacio stated he didn't know what I was taiking about when I asked him if he had a conflict with a woman earlier. He stated he didn't do anything and had no clue what I was talking about. He denied ever meeting someone at his house but he did ask if she was here legally.

Jennifer was driven to my location and she gave a positive ID that Nicaclo was in fact the person who grabbed her ID and ripped it off her neck causing her neck to have pain. Jennifer filled out a witness statement and was sworn to and stated she wished to press charges on Nicaclo.

Nicacio was arrested at that point for Simple Battery Intentionally grabbing the ID that was attached to a lanyard around Jennifer's neck. He was placed into handcuffs which were double locked and checked for proper fit. While searching Nicacio I located Jennifer's ID in his right front pocket. When I asked how he got this ID he stated he found it on the ground she dropped it. Nicacio was transported to the Palm Beach County jall and booked for the listed charge without incident.
