The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/14/2022 at approximately 0254 hours, affiant and a backup officer responded to the listed address regarding a report of a disturbance. The defendant was encountered as he was urinating on a vehicle. During the subsequent contact, the defendant advised he was intoxicated and appeared to be intoxicated - he was slurring his speech and his eyes were bloodshot and watery. Author and backup officer attempted to call multiple people to pick up the defendant. When those attempts failed, the decision was made to take the defendant into custody under the authority of the Marchman Act. The defendant said that if we attempted to take him into custody, one or both of us would "have our jaws broken." Author attempted to take the defendant into custody by grabbing his right hand and the defendant pulled away and pushed the author away from him with his left hand. The defendant's actions required that he be taken to the ground, where he continued to resist lawful efforts by both officers to take him into custody by refusing to place his hands behind his back. The defendant was identified on scene by his Florida driver license.
