The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did Cpl T. Hart stopped a gray Toyota Tundra (NJ H39NKT) for driving in the wrong direction on a one-way street. He went north in the southbound lanes on N 21st St from E 5th Av. During observations, the driver, Nicholas Dibuono, displayed indicators of impairment to include having red glassy eyes, slurred speech, and the distinct odor of an alcoholic beverage on his breath. He was arrested for DUI after he displayed additional indicators of impairment during SFST's. He was taken to CBT where he was read implied consent before he took the breath test. He provided breath samples of .100/ .098. Dibuono's identity was verified using his state of NY driver's license. He has a state of NJ medical marijuana identification card. During an inventory search, Ofc J. Tamargo found 24 grams of marijuana inside Dibuono's vehicle. It was field-tested with positive results by Cpl Hart. The marijuana was not n a proper package per Florida state law. It was in a clear vacuum-sealed package with no markings, the test contained more than .03% THC. Dibuono was charged with felony possession of marijuana. The marijuana was placed into evidence at the impound lot.
