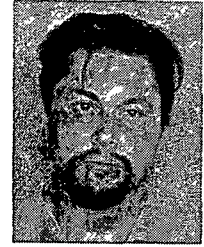

Before me this date personally appeared SMITH, AUSTIN (1015) who being first duly sworn deposes and says that on 24 day of April, (year) 2022 at   (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

he wrapped his arms around her and tried to drag her back into the house.   bit his right arm several times until he released her.   was able to grab her car key, open the garage door, and enter the garage. Nicolas wrapped his arms around her again to drag her back inside, and both of them fell to the floor.   broke free and entered the driver's seat of her vehicle. Nicolas jumped into the driver's seat on top of   to prevent her from driving.   pushed him off of her, and then he went back inside the house.   came to the PD to make the report. I could see black dirt marks on   left thigh and left foot that she says were from the fall. There was also a freshly bleeding scratch and bruise on   left thigh that she says she believes were from Nicolas grabbing her.

I responded to 2801 Oakview Way and met with Nicolas. He had a bloody lower lip as well as a bite mark on his left shoulder. Nicolas said that he and   had a verbal argument today, and she wanted to leave. As she went to leave he wrapped his arms around her to prevent her from being able to leave. He initially said he had an accident that caused his bloody lip, then said it was from a slap from   during their argument, then said it was from a punch. After saying these things, Nicolas did not want to speak any more or clarify his statements.

Based on my observations and statements made, Nicolas was taken into custody.
