The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did Nicole Hassan was driving her blue Nissan Sentra bearing (NY KFX1114) northbound on Nuccio Pkwy from E 7th Av. She lost control of the vehicle, drove onto the sidewalk. The vehicle knocked down a speed limit sign and a decorative light pole and came to final rest on its roof. The crash caused an estimated \$5000 in property damage. Hassan and her passenger sustained minor physical injuries from the crash. They were treated on scene by Tampa Fire Rescue. Post Miranda Hassan stated she was the one driving the vehicle. The passenger also stated Hassan was the driver and Hassan had seatbelt marks on her chest that went from left to right. During observations Hassan's eyes were red and glassy, her speech was slurred, and there was the distinct odor of an alcoholic beverage on her breath. She displayed additional indicators of impairment during SFST's and was arrested for DUI. She was taken to CBT where she took the breath test. She provided breath samples of .139/.138. Hassan's identity was verified using her state of NY driver's license.
