The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the above date and time, I Trooper Warren N Reid was conducting speed enforcement on Interstate 4 and parked my patrol car at the emergency turn around in the vicinity of the scale house. I was parked facing east and observed a vehicle traveling westbound towards me traveling at 98 MPH.

As the vehicle passed, I activated the emergency lights and effected a traffic stop. I approached the passenger side and informed the defendant that she was stopped for exceeding the speed limit. While talking to the defendant, I could smell the strong odor of consumed alcohol emitting from her breath. I requested her driver's license and documents for the vehicle which she provided. Defendant was identified by her Florida Driver's License as Nicole Lee Jacobson, DOB 09/18/1990. I prepared a citation for speeding, walked back to the driver's side, and while talking to the defendant, I could still smell alcohol. I also observed her watery eyes. I informed the defendant that I have reasonable suspicion that she was under the influence of alcohol, and I would be requesting her to perform some FSE's to determine her blood alcohol content. She performed poorly on the HGN, the Walk and Turn and the One Leg Stand. The defendant was then placed under arrest, and placed in the back seat of my patrol car prior to being searched by a female Deputy for HCSO. I asked the defendant if she would provide a breath sample at the jail and she said no. I read her the Implied Consent Warning and she still refused. The defendant was later transported to the breath testing center and was given another opportunity to provide a breath sample and she refused. She was later booked in jail on the charge listed in this report.
