The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date and time, I Trooper Winter (4596) was dispatched by the Tampa Bay Regional Communications Center for a single vehicle crash located on US-301 (SR-41) and County Road 579 (Mango Road). I arrived on scene and immediately noticed a Gray 2017 Land Rover FL License Plate Number PTAA05 which was located on the west shoulder of US-301 (SR-41) on its left side. I approached the driver (who was later identified by FCIC/NCIC as Nicole Marie Warren Texas DL #41263109) who was sitting on the grassy shoulder. I asked Ms. Warren what happened and she stated that she tried to avoid a crash so she slammed on her brakes and ended up rolling over. While Ms. Warren was explaining the series of events, I noticed a strong odor of an alcoholic beverage emitting from her breath, along with bloodshot watery eyes, slurred speech and had a very difficult time maintaining her balance. After understanding how the crash occurred at approximately 0339 am I read Ms. Warren her Miranda Warnings, while reading Miranda, she stated she understood her rights but would not give me a proper response, Ms. Warren would not properly respond to my "yes" or "no" questions. While Ms. Warren stood there she stated, "I don't know what to say, I fucked up, like, the car swerved in front of me, and I fucking crashed the car that wasn't registered to me and I fucked up, I know." I later asked Ms. Warren if she had her car keys on her, which she did (inside her purse that she was carrying). At approximately 0356, I asked Ms. Warren if she would be willing to perform Field Sobriety Exercises, she accepted and then shortly after, denied. I told Ms. Warren that if she refuses to Perform Field Sobriety Exercises then based on my observations, I would have to place her under arrest for DUI. I asked Ms. Warren a second time, she refused once more. At approximately 0401 am I placed Ms. Warren under arrest for DUI. I had Deputy Monroe with the Hillsborough County Sheriffs Office have a female Deputy come to the scene and properly search Ms. Warren. A little while later, Deputy Yockey arrived and conducted a search. Ms. Warren was properly handcuffed, double locked and searched. Implied consent was read on scene at approximately 0407 am and Ms. Warren refused to submit to a breath sample. I placed Ms. Warren in the back of my patrol vehicle FHP1573 and transported Ms. Warren to Orient jail where she was turned over to Hillsborough County Deputies for further booking procedures.
