During the same call for service, Povalaram stated that her personal information (name, date of birth, social security number and driver's license number) was being used by Mathimaran and his new wife, Bhargavi Narra, to apply for jobs for Narra. Povalaram and Mathimaran divorced in November of 2020 where Mathimaran moved into his new residence with his girlfriend (now wife) Bhargavi Narra. According to Povalaram, Narra left her husband in India and ran away with Mathimaran to the United States. Povalaram claims Narra doesn't have the proper paperwork to legally work in the United States. Povalaram never gave permission to anyone to use her information to apply for employment.

Povalaram stated she started receiving phone calls from job applications she didn't fill out. On April 14, 2021, Polavaram (amulya30@yahoo.com) received a forwarded email from "Amulya Nirmal (amulyanirmal30@gmail.com)" that stated "FYI" with an attached email in the thread. The email, dated April 13, 2021 at 1854hrs, was sent by Carrie Frash, Director of People & Culture with a company called Acuant, and offered "Amulya" a job position with their company as a Technical Writer. Polavaram said she never applied for this job and

has never done work as a Technical Writer. Polavaram said Mathimaran and his new girlfriend "Bhargavi" are both Technical Writers and she is a Software Test Engineer.

Povalaram stated she received information on another job application to a company named Abacus Service Corporation. The job application, dated April 29, 2021, had all of Polavaram's personal information (Maiden Name, Social Security Number, Driver's License Number and Address) and was digitally signed "Amulya Nirmal". Polavaram pointed out the phone number used on the application was 561-670-3252 and the email used was amulyanirmal30@gmail.com, both of which are not hers. Next, Polavaram pointed out the two references were "Matt" with a phone number of 561-870-7786 and "Bhargavi Narra" with a phone number of 761-961-6983. Also included with the application was a W4 form with the name "Amulya Nirmal" and Polavaram's home address. Lastly, the "Applicant Certification" portion of the application was digitally signed by "Amulya Nirmal" on 4/29/2021.

An investigatory subpoena was sent to T-Mobile for phone numbers 561-670-3252 and 561-870-7786. T-Mobile stated both telephone numbers are registered to Nirmal Mathimaran, the account has been active since 7/9/2018 and was currently active at the time of the records request.

An investigatory subpoena was sent to Google for email address amulyanirmal30@gmail.com. Google stated the account was created on 11/15/2020 with an IP Address of 164.68.159.68 (Hotwire Communications). Account recovery telephone number was 561-870-7786 (Nirmal Mathimaran) and recovery email address was bnirmal30@yahoo.com (Nirmal Mathimaran).

An investigative subpoena was sent to Hotwire Communications for IP Address 164.68.159.68. On March 22, 2022, Sean Simmons, Junior Corporate Counsel for Hotwire Communications, replied stating the Hotwire team wasn't able to locate any information on the IP address due to the timeframe being removed from their servers. Simmons stated their servers only hold 26 weeks of information before the information is deleted. Simmons was able to confirm that Mathimaran did have service with Hotwire Communications between 10/20/2020 and 10/19/2021 at 5160 Las Verdes Circle #109, Delray Beach, Florida, 33484. The amulyanirmal30@gmail.com email address was created on 11/15/2020 using the Hotwire Communications issued IP Address.

In a follow up email, Simmons stated the following:

According to records from Engineering, that subnet was deployed to:

LAS-VERDES, 5121 Las Verdes Cir. Delray Beach, FL 33484 02/Dec/19 8:27AM description LAS-VERDES-DATA-OLT-01 ipv4 address 164.68.156.1 255.255.252.0 It remains in use at that location today.

Utilizing an IPV4 Subnet Calculator, a tool that returns a variety of information regarding IP address subnets including possible network addresses, the 164.68.156.1 IP Address, coupled with a 255.255.252.0 subnet, will allow for a total of 1,022 usable hosts (assignable IP addresses) and an IP Range of 164.68.156.1 – 164.68.159.254. IP Address 164.68.159.68 falls into that range of usable hosts provided by that configuration.

On February 25, 2022, I spoke with Carrie Frash with Acuant who provided me information on "Amulya Nirmal's" application with her company. The job application sent to Acuant listed Povalaram's home address but showed an email address of amulyanirmal30@gmail.com and a telephone number of 561-670-3252.

Polavaram's email address is amulya30@yahoo.com and her phone number is 561-418-4481. The application also listed a resume provided by "Amulya Nirmal" that listed an Indeed account (amulyanirmal307_j5z@indeedmail.com).

Frash's colleague, Lynette Vallecillo, said she spoke to "Amulya Nirmal" on the telephone from telephone numbers 603-935-4149 and 770-853-1956. I checked the call records for the 561-670-3252 number to see if it had communicated with any of Recruiter Vallecillo's phone numbers between 4/1/21 to 5/1/21. In the call records, 9 phone calls were located; 2 phone calls were made between 3252 and 4149 and 7 phone calls were made between 3252 and 1956.

An investigative subpoena was sent to Indeed, Inc for Indeed.com account amulyanirmal307_j5z@indeedmail.com. This account was located on a resume for "Amulya Nirmal" that was submitted to Acuant in March of 2021. Certified documentation from Indeed, Inc. showed the account listed amulyanirmal30@gmail.com as the email address, an IP Address of 164.68.159.68, a phone number of 561-870-3346 and showed the account was created on December 9, 2020.

In summary, Amulya Nirmal (Povalaram) is alleging her ex-husband, Nirmal Mathimaran, forged her signature on the back of a \$21,213.78 check that was issued for the purpose of repairing the roof at their once shared residence. Shortly after Povalaram and Mathimaran divorcing, Mathimaran and Narra began completing Technical Writer job applications using Povalaram's personal information including her name, address, social security number and driver's license number but utilizing a different email address (amulyanirmal30@gmail.com) and phone number (561-670-3252). Two job applications were found where the aforementioned email address and phone number were used in conjunction with Povalaram's personal information. Investigation revealed the phone number is registered to Mathimaran and the email address was created by and is in use by Mathimaran. Both the amulyanirmal30@gmail.com email address and Indeed Inc profile (amulyanirmal307_j5z@indeedmail.com) were created by the same IP address (164.68.159.68), which is linked to Mathimaran's residence at Las Verdes in Delray Beach, Florida. Both accounts were discovered to have been created inside the timeframe that Mathimaran and Narra lived at Las Verdes (10/20/2020 and 10/19/2021).

Due to the facts of the case and the above described investigation, I find probable cause to charge Nirmal Mathimaran and Bhagari Narra with 2 counts of Criminal Use of Personal Identification Information pursuant to FSS 817.568(2A).
