The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 6/12/2022, at approximately 0254 hours, HCSO received multiple 911 calls in reference to a male passed out within a vehicle in the area of West Hillsborough Avenue and Eisenhower Boulevard. The vehicle was blocking traffic from flowing through the traffic light. Florida Highway Patrol Trooper Kope #4728 was on his way home when he pulled behind the vehicle (a silver Mazda bearing Florida tag HDA-B80) and observed the light to cycle and the vehicle not move. Trooper Kope walked up to the vehicle and found the defendant asleep behind the wheel of the vehicle, which was running. When Trooper Kope was able to wake the defendant he detected several indicators of impairment to include bloodshot/glassy eyes, slurred speech, admission to alcohol consumption and an odor of an alcoholic beverage emanating from his breath. Affiant responded to the scene and detected the same indicators of impairment from the defendant. The defendant agreed to perform SFSE's where cues of impairment were observed. The defendant was arrested and later provided a lawful breath sample that resulted in a BrAC of .111/.100. The defendant identified himself verbally which was confirmed via a valid Florida driver's license.
