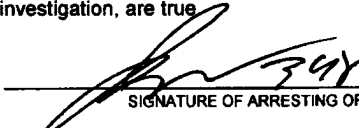

Cutshaw was brought to this location by her mother, WF Pamela M Watson 6/7/75 and her mother's fiancé, WM Douglas T Pearsall 7/20/64. Upon arrival, I made contact with these three individuals by their vehicle which was parked next to 1300 Via Royal. While speaking to them, Watson became loud and verbally aggressive in tone. She was frustrated about allegations her daughter had made from earlier. I told her she was not helping the situation with how she was speaking. Her daughter and fiancé affirmed my statements to her however she disregarded them. I then went up to the apartment to make contact with Rothfleisch. I advised him that Cutshaw was present and wished to retrieve her belongings. Ofc Shaff arrived on scene and assisted with the standby while Cutshaw came up to the apartment.

While inside the apartment, I could hear loud screaming of obscenities from a woman's voice which I recognized as Watson. I stepped outside to observe what was happening and could hear her voice getting louder. I then requested more units to respond due to the disturbance Watson was causing. I then observed Watson coming up the last flight of stairs to the landing of Rothfleisch's unit. She was followed by Pearsall who was trying to calm her down. As she reached the top of the landing, I told her to go back downstairs as this situation did not involve her. She continued yelling obscenities at me and at her fiancé and made physically aggressive advances towards the apartment door. While she was screaming at me, I detected the odor of an unknown alcoholic beverage emanating from her person which became stronger each time she was screaming. Additionally, her eyes were bloodshot and glassy. She also began to urinate on herself. Pearsall continued his attempts to verbally calm her down and physically keep her away from the apartment door. Neighbors in adjoining units were looking out their door to see what was happening. At one point, Watson swung her right hand and smacked Pearsall across the left side of his face with an open hand. I then rushed over, separated the two, and placed Watson in handcuffs that were checked for spacing and double locked. She was then taken downstairs, searched, and placed in a patrol car. While at the Police Station, Watson denied Pearsall being her fiancé and called him her boyfriend. She did however admit he lives with her 2 weeks out of the month.

I later spoke to Pearsall later who had questions about the arrest process. During this conversation, he confirmed Watson had been drinking prior to arrival at the apartment complex. He also stated multiple times on scene that Watson was his fiancé as opposed to his girlfriend. He was ultimately issued a Domestic Violence Victim's Rights brochure along with a case number and released from the scene.

Based on Watson's apparent intoxication and disturbance she was causing, I find probable cause to arrest her for Disorderly Intoxication because she was intoxicated and endangered the safety of another person or property, or was intoxicated or drank an alcoholic beverage in a public place or in or upon a public conveyance and caused a public disturbance, contrary to Florida Statute 856.011(1).

Furthermore, when I witnessed Watson smack her boyfriend across the face, probable cause was established to arrest her for Domestic Battery because she did actually and intentionally touch or strike *(Douglas Pearsall) against the will of *(Douglas Pearsall) *(Douglas Pearsall) was a family or household member of *(Pamela Watson), contrary to Florida Statute 784.03(1), 741.28 and 741.283.

Watson was transported to the Jupiter Police Station where she was advised of her charges and processed. She was later transported to Palm Beach County Jail where she was booked under the above charges.

The above incident was captured on my BWC. The narrative is a summary of the BWC footage and not purported to be verbatim.
