[REDACTED] provided me a receipt for the items Paola stole, which amounts to \$144.96 of makeup products He showed me video which shows Paola scan her package of cookies, and then pretend to scan the other items In the video, the items Paola pretends to scan have the UPC code facing up and away from the scanner, where they could not be scanned

[REDACTED] signed an affidavit in favor of prosecution on behalf of Walmart Paola was taken into custody for petit theft/shoplifting She was then transported to BSO Main Jail without incident
