The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 6/12/22 at approximately 2046 hours, the witness was operating his motor vehicle eastbound on Phoenix Cir. The witness observed the defendant laying on the ground in front of 11702 Phoenix Cir. The defendant's black motorcycle, bearing FL tag MQLF76 and VIN JYA3AWE00NA176128, was laying on top of the defendant. The motorcycle had damage consistent with a single vehicle crash (24638717-01). The damages were approximately \$1000. The witness moved the motorcycle off the defendant. Deputies shortly after made contact with the defendant and verified he did not live at the above listed address. The defendant refused to be transported to the hospital to receive treatment and denied having any injuries. No visible injuries were observed. While in contact with the defendant, several deputies observed the defendant to have several indicators of impairment. The affiant responded to the scene and observed the defendant to have bloodshot and glassy eyes, and the odor of an alcoholic beverage emanating from his breath. The defendant was advised of the observed indicators. The defendant refused to complete Standardized Field Sobriety Exercises. Implied consent was read and understood. The defendant continued to refuse to provide a lawful breath sample. The defendants identity was confirmed via FL DL.
