The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 1/13/2021 a approximately 2004hours, the defendant was involved in a traffic crash with the victim. The defendant was operating a silver Honda Civic bearing FL tag NMKS17 at the time of the crash. The traffic crash investigator estimated approximately \$7500 of damage caused by the crash. The defendant stated several times "I shouldn't have been drivin" and I observed bloodshot watery eyes and a very strong odor of alcoholic beverage on his breath. I also observed the defendant to have very slurred speech that was at times almost unintelligible, and lethargic movements. The defendant was also confused as to his location and continued to claim he was on a different roadway. The defendant refused to complete the SFSE's. I advised the defendant the SFSE's are to dispel my belief he was to impaired to be driving and he again said that's ok. Based on the totality of the circumstances, I placed the defendant under arrest. I requested the defendant provide 2 lawful breath samples on the mobile intoxilyzer in my vehicle and he refused. I read to him implied consent and he again refused. I issued the defendant DUI citation AE94WME. The defendant identified himself verbally and was confirmed via DAVID.
