ON MONDAY, SEPTEMBER 11TH, 2017 AT APPROXIMATELY 0652 HRS, I WAS ASSIGNED TO THE HOLLYWOOD POLICE DEPARTMENT. AT THE TIME, I WAS RIDING AS A TWO MAN UNIT WITH OFFICER ALLEYNE. OFFICER ALLEYNE WAS OPERATING MY UNMARKED POLICE VEHICLE DUE TO WEATHER CONDITIONS AND LARGE DEBRIS/FLOODING IN THE AREA CAUSED BY HURRICANE IRMA. THE UNMARKED POLICE VEHICLE IS EQUIPPED WITH EMERGENCY RED AND BLUE LIGHTS AND SIREN.

STEVEN</u> (3297) who being first duly sworn deposes and says that on 2017 at 1400 HOLLYWOOD BLVD, HOLLYWOOD, FL 33020 11 day of September (year) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows.

ON THE ABOVE DATE AND TIME, OFFICER ALLEYNE AND I WERE TRAVELING WESTBOUND ON HOLLYWOOD BLVD IN THE 1400 BLOCK. WHILE TRAVELING IN THE RIGHT THRU LANE, OUR VEHICLE WAS STRUCK IN THE REAR BY A RED JEEP CHEROKEE (FL TAG# ENS-T90). OFFICER ALLEYNE PULLED OUR POLICE VEHICLE OVER TO ASSESS ANY INJURIES AND DAMAGE FOR THE PURPOSE OF THE INVESTIGATION. THE DRIVER OF THE JEEP, LATER IDENTIFIED BY HIS FLORIDA DRIVERS LICENSE AS PATRICK QUERE, FAILED TO STOP AND QUICKLY ACCELERATED HIS VEHICLE WESTBOUND ON HOLLYWOOD BLVD, PASSING OUR VEHICLE IN A CLEAR ATTEMPT TO LEAVE THE SCENE OF THE ACCIDENT.

OFFICER ALLEYNE THEN ACTIVATED OUR EMERGENCY EQUIPMENT (LIGHTS AND SIREN) TO CONDUCT A TRAFFIC STOP ON THE VEHICLE. QUERE CONTINUED ACCELERATING AWAY FROM OFFICERS, WHO WERE NOW ACTIVELY ATTEMPTING TO STOP HIS VEHICLE. QUERE THEN MADE AN ABRUPT SOUTHBOUND TURN ONTO S 15TH AVENUE FROM HOLLYWOOD BLVD. QUERE TURNED HIS HEADLIGHTS OFF IN AN ATTEMPT TO BLEND IN WITH THE DARKNESS AND LOSE VISUAL OF HIS VEHICLE. QUERE THEN MADE A RIGHT TURN TO TRAVEL WESTBOUND ON HARRISON ST, STILL ACTIVELY FLEEING FROM OFFICERS AND STILL ACCELERATING HIS VEHICLE. QUERE THEN ABRUPTLY PULLED HIS VEHICLE OVER IN FRONT OF 1535 HARRISON ST. OFFICER ALLEYNE RESPONDED TO QUERE'S SIDE OF THE VEHICLE AND ATTEMPTED TO ESCORT QUERE OUT OF THE VEHICLE. QUERE BEGAN TO TENSE AND ATTEMPTED TO PULL HIS ARM AWAY. QUERE THEN USED HIS RIGHT HAND TO GRAB THE STEERING WHEEL PREVENTING OFFICER ALLEYNE FROM PULLING QUERE OUT OF THE VEHICLE. AFTER ATTEMPTING TO REMOVE QUERE FOR SEVERAL MOMENTS, HE SUDDENLY RELEASED THE STEERING WHEEL AND WAS ESCORTED TO THE GROUND. QUERE STRUCK HIS HEAD ON THE PAVEMENT AND SUSTAINED A SMALL LACERATION TO HIS FOREHEAD. QUERE WAS PLACED INTO CUSTODY.

WHILE ATTEMPTING TO PLACE QUERE INTO THE POLICE VEHICLE, OFFICER ALLEYNE ADVISED THAT
