<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:</p> <p>On the listed date, time, and location, I observed a vehicle to be stationary in the travel lane impeding the flow of traffic. I conducted a welfare check on the driver (later identified as Patrick Lewis Richardson via FL DL R-263-672-73-099-0) who was sitting in the driver's seat. The vehicle engine was running and the vehicle was in drive. I observed the driver to be sleeping. I then Knocked on the driver's window to wake Mr. Richardson up. Mr. Richardson opened the window, I could smell a strong odor of alcoholic beverages emanating from the vehicle. I then asked Mr. Richardson if he was feeling okay. Mr. Richardson answered saying he was "fine". I then asked Mr. Richardson to step out of his vehicle. While speaking with Mr. Richardson, I could smell a strong odor of alcoholic beverages emanating from his person. I also observed Mr. Richardson have slurred speech and bloodshot glassy eyes. Mr. Richardson was unsteady on his feet and had difficulty keeping his balance. I asked Mr. Richardson if he suffered from any medical condition. Mr. Richardson stated he does not have any medical issues. I then asked Mr. Richardson if he was willing to perform a field sobriety exercise and he refused. Mr. Richardson was then placed under arrest for Driving Under the Influence (DUI). Mr. Richardson was transported to Orient Road Jail without incident. Mr. Richardson was asked to provide a breath sample. Mr. Richardson refused to provide a breath sample. I then read Mr. Richardson's Implied Consent at 03:05 PM, and he agreed to provide a breath sample. Mr. Richardson completed his 20 minutes observation, under my supervision and provided a breath sample of 0.254 and 0.246 without incident.</p> <p>All events occurred in Hillsborough County Florida</p>
