The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a red 2021 Toyota Camry (FL Tag #RPL7) northbound on Howard Av N at a high rate of speed, weaving in and out of traffic aggressively and over taking them. After catching up to the vehicle, I paced it at 75 MPH in a posted 40 MPH zone.

During the traffic stop for speeding infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, slow/deliberate movements, lethargic appearance, confusion with his paperwork, fumbling fingers, he admitted to drinking "1 beer" prior to driving, and emitted a distinct odor of an alcoholic beverage from his breath.

The defendant was arrested for DUI following a poor performance on SFSEs and was transported to booking.

While at CBT, the defendant was read Implied Consent and agreed to take a breath test. He provided 2 valid samples, measuring .108/.108 BrAC.
