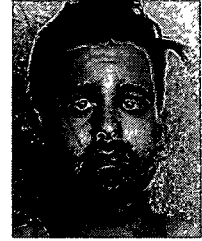

Before me this date personally appeared **BROWN, RUSSELL (6636)** who being first duly sworn deposes and says that on **31** day of **March** (year) **2022** at **2600 E LAS OLAS BLVD, FORT LAUDERDALE, FL 33301** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On March 31, 2022, at approximately 2:00AM in the 2600 block of E Las Olas Blvd in the city of Fort Lauderdale, County of Broward and State of Florida, there was a traffic crash involving one vehicle and one bicyclist. Officers located the vehicle at 2 Fiesta Way, Fort Lauderdale, FL. Officers made contact with the occupants. The driver was identified as Pedro Ramon Fluriach (03/03/1985). The passenger was identified as Marquis Jackson (10/29/1989). Jackson advised Fluriach was driving when they hit something on

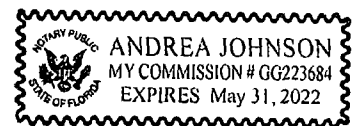

Probable Cause Affidavit

Before me this date personally appeared BROWN, RUSSELL (6636) who being first duly sworn deposes and says that on 31 day of March, (year) 2022 at 2600 E LAS OLAS BLVD, FORT LAUDERDALE, FL 33301 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

the bridge. The vehicle was a black 2010 GMC Sierra bearing Florida tag GHGU76 with heavy front-end damage. The vehicle was missing the passenger side headlight and there were several pieces missing from the vehicle which were located at the scene. The damage is consistent with that of striking the bicyclist.

Post-Miranda defendant Fluriach admitted to operating his black 2010 GMC Sierra, westbound on E Las Olas when he struck something. Fluriach advised the airbags deployed, and the hood went up into the windshield. Fluriach continued driving westbound and turned north on Fiesta Way when he was pulled over by police. Fluriach had the opportunity to stop at least three other streets before deciding to turn on Fiesta Way which is over half a mile from the scene. The bicyclist was later identified as [REDACTED]. [REDACTED] died at the scene. Damage was also done to the bicycle belonging to the victim. Defendant Fluriach failed to stop, render aid, or call 911. Due to an odor of an alcoholic type of beverage a DUI investigation was initiated. A warrant was obtained for a blood draw. Results are pending. Due to the aforementioned facts, I have probable cause to author this affidavit.
