Communication Center (LWRCC). Advised of a wrong way driver traveling northbound on the southbound express lanes from Copans on Interstate 95 (State Road 9) out of Broward County. The vehicle continued to travel northbound on the southbound lanes which was a Black Nissan Altima with a North Carolina bearing tag of (FKL8386).

Sergeant Alarcon (3254/324) Informed (LWRCC) that he had a visual of the vehicle southbound Interstate 95 south of Spanish River Blvd. Sergeant Alarcon (3254/324) was able to use the Precision Immobilization Technique (PIT) maneuver on right rear side of the black Nissan Altima that was driving the wrong way. I informed (LWRCC) that I was enroute from southbound Interstate 95 (State Road 9) north of Congress Avenue. Upon my arrival on Scene, I observed a black Nissan Altima Facing in a Southwesterly direction and white female wearing a black dress standing outside next to the vehicle. Fire rescue personnel arrived on scene to medically access Ms. Lenz.

The driver which was Ms. Lenz was identified by her Florida driver license of (L520-662-00-832-0) as Peyton Brooke Lenz. Upon talking to Ms. Lenz, I immediately detected the odor of an unknown alcoholic beverage emitting from her breath as she talked. I informed Ms. Lenz and advised her that I was beginning a criminal investigation for driving under the influence (DUI). Ms. Lenz agreed to voluntarily perform the Field Sobriety Exercises.

SFSE's were conducted on the side of the roadway southbound south of Spanish River Blvd. The ground was even and free of debris and a red-light was used as a stimulus for Horizontal Gaze Nystagmus. Yellow tape line was used for the walk and turn.

Before beginning the exercises, I checked to see if Ms. Lenz was wearing glasses and contacts. It was determined that Ms. Lenz was not wearing glasses or contacts. Ms. Lenz was instructed to keep her head still and follow and stimulus with her eyes and her eyes only. She was also instructed to keep looking at the stimulus until told not to. Ms. Lenz verbally indicated that she understood all the

Horizontal Gaze Nystagmus

- Nystagmus prior to 45 degrees in both eyes.
- Distinct and sustained nystagmus at maximum deviation in both eyes.
- I observed the defendant with lack of smooth pursuit in both eyes.
- Equal tracking and equal pupil size were observed.

Walk and Turn

Ms. Lenz advised she understood the instructions explained.

During the walk and turn I observed the following;

- Ms. Lenz performed more than 9 steps forward missing several heal to toe and did not turn continued going in the same direction.
- Ms. Lenz used her arms for balance
- Ms. Lenz unable to maintain balance at the begin of the exercise.

One Leg Stand

Ms. Lenz advised she understood the instructions explained.

During the one leg stand I observed the following;

- Ms. Lenz started the exercise without being told to.
- Ms. Lenz did not count out loud like told to.
- Mr. Lenz walk heal to toes step instead of doing the exercise like instructed to.

Based upon the above information and the totality of the circumstances, I believe that Ms. Lenz committed the offense of driving under the influence. Ms. Lenz was placed under arrest at 1:23AM and charged with F.S 316.193.1a DUI I transported Ms. Lenz to the Palm Beach County Breath Alcohol Testing (BAT) facility. After a 20-minute observation period was conducted, Ms. Lenz did not take anything by mouth or regurgitate. I then requested that she provide a sample of her breath. Ms. Lenz agreed. She provided a first breath test sample of 0.163 and a second breath test sample of 0.167. She was then read her rights from a prepared Constitutional warning document provided by the BAT facility. She stated that she understood
