The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 04/02/2022 at approximately 0306 hours, a call for service was received after the eyewitness found the defendant asleep in the drivers seat of her running gray 2012 Volkswagen sedan with Florida tag CZUD90 just north of the intersection of MacDill Av N and Columbus Dr W. The vehicle had struck a metal street sign causing approximately \$500 in damage to her vehicle. Units responded to the scene, observed indicators of impairment, and requested a DUI investigation be conducted. I responded to the scene and made contact with the driver/defendant who was observed to have glassy/bloodshot eyes, dilated pupils, a noticeable sway while she stood, slurred speech, and the odor of an alcoholic beverage coming from her breath. During a post-Miranda statement, the defendant admitted to drinking prior to driving. The defendant exhibited clues of impairment during SFSTs and was arrested for DUI. The defendant submitted to the requested breath testing which produced a BrAC of 0.152/0.154. The defendant was positively identified via DHSMV photograph.
