

The defendant became upset because she was not receptive to his parenting style attempted to avoid the defendant by walking off into her son's room with their daughter The defendant followed her into the next room and continued the verbal altercation advised she returned to the master bedroom with their daughter, at which point the defendant took the baby from the victim before placing her in the crib stated she attempted to secure her cellphone with the intention of contacting 911 but did not announce this to the defendant The defendant snatched the phone out of her hand, which led to a physical altercation advised the defendant grabbed both her hands before throwing her onto the bed then stated she bit the defendant twice on both arms and lower back area in an attempt to escape, however, the defendant struck her once across the face causing bruising to her lip and a knot to her right temple I then spoke to the defendant, who advised a verbal argument ensued because he felt she was excluding him from spending time with their daughter. The defendant denied attacking and stated she injured him during the verbal altercation The defendant was read his Miranda Warning via pretext card by this officer, which he walved, desiring to speak to me The defendant advised he became upset because the victim did not fully respect his decisions as a parent and man.
