I got behind the vehicle and I observed the vehicle drifting inside the lane of travel and failing to maintain control of the said lane. I observed the vehicle cross the dividing lane while maintaining a speed of at least 65 mph and swerve back into the lane of travel. I activated my emergency lights to conduct a traffic stop and the vehicle was slow to stop, eventually coming to a stop after entering the intersection at Jog Road and Pipers Glen Blvd. I asked the driver, via my in-car PA system, to make the left-hand turn so the vehicle was not in the intersection. The driver made a u-turn instead of the left-hand turn and stopped in the southbound lane of Jog Road. I made contact with a female driver, later identified by her Florida Driver's license, as Priscilla Villedrouin. As I approached the vehicle I observed Villedrouin's eyes were watery, glossy and bloodshot. When Villedrouin began to speak, her speech was slowed and slurred. I asked Villedrouin for her driver's license, registration, and insurance. Villedrouin was unable to keep her attention focused on obtaining the items I asked for. I had to ask multiple times for Villedrouin to hand me her registration and insurance. The defendant stated it was her birthday weekend and she had one drink. I asked the defendant what kind of drink she had and she stated she did not know. The defendant stated "this is bullshit, I was lost and trying to make a u-turn." After asking Villedrouin to exit the vehicle I noticed she was unsteady on her feet and was having trouble maintaining her balance while standing. 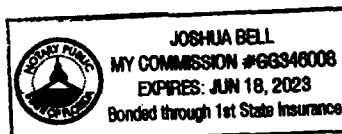

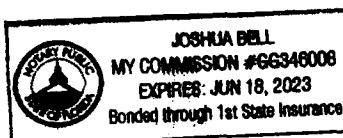
