The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a black 2012 Honda Civic, 4 door, Pennsylvania tag JNV5463. The defendant drove in a manner in which her vehicle was weaving in the travel lane, drifted in the travel lane, drifted onto and/or over painted lane markers numerous times, and she had difficulty maintaining a consistent speed as her speeds fluctuated up and down. The defendant also drove at speeds well in excess of the properly posted 55 MPH speed limit. The defendant drove at speeds up to 81 MPH, which was visually estimated and patrol car paced (TPD DUI unit 5055). A traffic stop was initiated for unlawful speed, as well as to check on the welfare of the driver to determine if she was sick, tired, or impaired. The defendant stopped inappropriately by stopping in the outside travel lane of the roadway at an exit ramp from I-275. The defendant had a dazed look about her face. The defendant's eyes were bloodshot, glassy, and watery. The defendant's speech was slurred, and her face was flushed. The defendant had a strong and distinct odor of an alcoholic beverage on her breath. The defendant stated she did consume alcoholic beverages tonight, and a drinking glass with straw was located on the passenger side floorboard that contained a fruity smelling alcoholic beverage. The defendant fumbled with documents displaying poor dexterity. The defendant was unsteady exiting the vehicle, and she swayed while standing. The defendant eventually agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and she had difficulty following simple instructions. Based on a totality of the circumstances the defendant was arrested for DUI. The defendant refused to submit to a lawful test of her breath for the purpose of determining its alcohol content after she was read the Implied Consent Warnings. The defendant was positively identified by her PA DL.
