The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/25/2022, near the intersection of West Bloomingdale Avenue and South Kings Avenue, Brandon, Florida 33610 Deputy J. DiBiase ABN: 261398 observed the defendant in physical control and operating a white 2018 Infiniti Q60 bearing Florida tag QQYB31 with an assigned VIN of JN1EV7AP1JM591285 driving well above the listed speed limit and failing to maintain a single lane. Upon Deputy DiBiase's contact with the defendant, he observed multiple indicators of impairment. While in direct contact with the defendant, I observed her to have watery/glassy eyes, she had slurred speech, she was unsteady on her feet, and I smelled the strong odor of an alcoholic beverage emitting from her breath. The defendant participated in the field sobriety exercises, and while doing so, she demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration she was placed under arrest for DUI. The defendant was transported to Central Breath Testing and she provided two lawful breath sample of .131 and .137. I further identified the defendant via her DAVID photograph.
