The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/14/2021 at approximately 0227 hours, I responded to the Seminole Hard Rock Casino located at 5223 Orient Road Tampa, FL. 33610 in regards to a Fight that occurred near the Plum room upstairs. Once on scene, I was advised the Victim was unconscious upstairs and Casino ERT's were rendering aid. I made contact with the Victim while upstairs. The Victim advised he was involved in a verbal argument with an unknown female later identified as Rachel Louise Gleaton (ID via FLDL). After the verbal argument he attempted to walk away walking up the stairs towards the Plum room. At this time, two unknown males followed the Victim upstairs. The Victim attempted to get away from the parties involved. Subject Gleaton got in front of the Victim, stopping him from getting away from the two males. Subject Gleaton grabbed and pushed the Victim while attempting to block the Victim from leaving the area. The Victim walked away from Gleaton. At this time, one of the male Subjects later identified as Todd C Labarge struck the Victim with a closed fist. A physical altercation with Subject Labarge, Subject Stephen Angelo Ippolito, and another female Subject identified as Tara Ippolito McDuffie (identified verbally and verified via DAVID) occurred. The physical altercation caused the Victim to fall to the ground and lose consciousness. While the Victim was unconscious, Subject Tara McDuffie kicked the Victim. I observed the Victim to have a bloody mouth. The Victim stated his head and neck hurt. The Victim was in and out of consciousness after the altercation. The Victim was transported to Tampa General Hospital for his injuries. This incident was captured on surveillance video. Subject Tara McDuffie was placed under arrest for Felony Battery and Subject Rachel Louise Gleaton was placed under arrest for Simple Battery.
