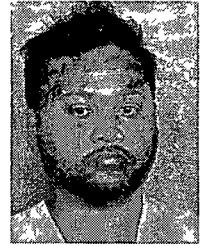

Probable Cause Affidavit

Before me this date personally appeared ODOR, ROBERT (18133) who being first duly sworn deposes and says that on 5 day of March (year) 2022 at 600 E OAKLAND PARK BLVD BLK, OAKLAND PARK, FL 33334 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Broward County, Florida Deputy Matthews CCN# 19491 was conducting a traffic crash investigation, during his investigation, I spoke to both drivers involved in the traffic crash The defendant was still behind the wheel of his vehicle, and the engine was still running When I spoke to the defendant, I observed a strong odor of an alcoholic beverage emitting from his breath, red/glassy eyes, and slurred speech

Deputy Matthews advised me that the defendant's vehicle, a 2013 White Lincoln MKX bearing FL Tag # RMP093 was turning westbound onto E Oakland Park Blvd from the Taco Bell parking lot located at the 600 block E Oakland Park Blvd At the same time, a 2013 black Honda Accord bearing FL Tag KQUL44 was westbound on E Oakland Park Blvd and struck the white Lincoln when it pulled in front of her No injuries were reported on the scene

The driver of the Honda Accord, wheel witness Blissett provided a sworn taped statement and identified the defendant as the driver of the white Lincoln MKX

I introduced myself to the defendant and advised him that the crash investigation was complete and that I needed to determine if he was okay to drive I asked him if he would answer some questions and perform some sobriety exercises He asked me what would happen if he refused I advised him that if he did not perform the exercises, I would have to determine whether or not to arrest him based on my observations so far and that he needed to dispel my concern that he is impaired I also advised him that it could be used against him court if he refused

He then said he would perform the exercises

During this encounter I observed the defendant to have an odor of an alcoholic beverage
