In the State of Florida, Palm Beach County, and the City of Riviera Beach, I utilized my body-worn camera (BWC). On May 29th, 2022, at approximately 0055 hours I was dispatched to 3800 N. Ocean Ave Room 1603 (Marriot Resort) in reference to a Domestic Battery by Strangulation. The caller stated [REDACTED] choked her and hit her in the head. Upon arrival, I made contact with W/F [REDACTED] (DOB 9/18/83), who provided the following sworn recorded statement: [REDACTED] later identified as W/M Lee, Randall (DOB 10/19/81), are here on vacation and were both intoxicated when they arrived at their hotel room. A heated argument started. [REDACTED] did not know why the argument started or who initiated it. As [REDACTED] walked into the walk-in closet, Randall allegedly followed her, continued yelling, then suddenly punched her in the front and side of her head. [REDACTED] attempted to block the punches and then ran to the couch. When asked about the strangulation allegation, [REDACTED] recanted her original claim of strangulation saying that Randall only punched her, but has battered her in the past. The following injuries were observed on [REDACTED]: a 1/4 inch purple abrasion over her left eye, 1/2 inch purple and blue abrasion over her left temple, and 3 total scratch with redness and red abrasion from the back of her left ear to her jawline. It should be noted the scratches and redness behind her left ear do appear to be consistent with strangulation however, [REDACTED] repeated denied being strangled. Due to her injuries, [REDACTED] was transported by medics to St. Mary's Medical Center under run

Randall was read his Miranda Rights, agreed on BWC that he understood the Miranda, and post-Miranda provided the following statement not to be taken verbatim:

Randall admitted to drinking tonight with [REDACTED] Randall agreed there was an argument, but denied striking [REDACTED] first. He alleged he was protecting himself after she started to strike him.

Randall had a two-inch scratch on the right side of his face from his eyebrow to his bread. Pictures were taken of his hands as well and there was no redness, abrasions, or cuts observed.

Photographs have been taken and uploaded.

Randall was taken into custody for violation of FSS 784.03(1) (A) (1) Simple Battery Domestic. He was transported to Riviera Beach Police Dept for processing.

W/M Lee, Randall DOB 20/19/1981 was transported to Palm Beach County Jail.
