The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 04/21/22 at approximately 2337 hrs, I was working uniform patrol in a marked patrol vehicle in the area Howard Av S and Azele Av W. I observed a red Volvo travel east on Azele Av W and stop at the stop sign at Howard Av S in the right turning lane. The vehicle then turned left on S Howard Av and headed toward Platt ST W. The vehicle then straddled the broken lane marker and caused a motorcycle to have to stop in the outside lane to avoid running into the rear of the red Volvo bearing Florida tag 35AKAR. The vehicle then turned right on Platt St W traveling east. I initiated my emergency equipment while the vehicle was in the outside lane. The vehicle continued to travel a block and half and then merge into the inside lane before finally stopping on the left hand side of the roadway. I contacted the defendant, Raquel Hernandez, who operating the vehicle. I immediately smelled the recently burned odor of Marijuana emanating from inside the vehicle. The defendant admitted to smoking Marijuana within the last hour. I asked the defendant to exit the vehicle and the defendant agreed to do FSTEs, HGN showed nystagmus and the walk and turn and one leg stand showed indicators of impairment. I took the defendant into custody and transported her to Central Breath Testing, where I read her Implied Consent for a urine sample. The defendant provided urine sample upon request, and she was booked into HCSO jail. The defendant was positively identified by her Florida drivers license.
