The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a black 2019 Dodge Ram 1500 pick up truck, Florida tag KAB10. The defendant left the roadway and struck a decorative mailbox post with 4 postal boxes attached, damaging the mailbox post and boxes. The defendant's vehicle then struck an unoccupied 2021 Buick Encore, 4 door, Pennsylvania tag JYY2006, which was parked on the side of the roadway. The defendant's vehicle front driver bumper impacted the Buick Encore on the front driver side bumper/grill. The Buick was then displaced backward, causing the rear bumper of the Buick to strike the rear bumper of a parked and unoccupied white 2020 Volkswagen Golf, hatchback, Virginia tag UEP2242. The estimated damage to the mailbox post and boxes is \$1,000.00; estimated damage to the Buick Encore is \$15,000.00; estimated damage to the Volkswagen Golf is \$1,000.00. After striking the mailbox post and Buick Encore, the defendant willfully drove away from the crash scene, only to be chased and stopped by witnesses. The listed witnesses were able to positively identify the defendant as being the driver of the Dodge pick up truck at the time of the crash and as being the sole occupant. During the civil crash investigation, observations of impairment were observed and a DUI Investigator was requested. I responded in this capacity. Upon making contact with the defendant, he had the strong and distinct odor of an alcoholic beverage coming from his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, his speech was slurred, and he swayed while standing. The defendant was advised the civil crash investigation was complete and a criminal DUI investigation was being conducted, and he was read his Miranda Rights. The defendant agreed to answer questions without an attorney present. During questioning the defendant stated that he was driving, that he struck a parked vehicle, and that he had consumed three alcoholic beverages today. The defendant admitted that he should not have been driving due to alcohol consumption, that he had made a mistake, and that he was impaired. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances he was arrested for DUI. The defendant provided breath samples of .167% BrAC and .163% BrAC. The defendant was positively identified by his Florida DL.
