The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 03/30/2022, at approximately 1240 hours, I responded to 11402 Mallory Square Dr, Tampa, FL in response to a battery (DV) call. Upon arrival, I learned that at approximately 1205 hours, the victim and the defendant were involved in a verbal argument that turned physical. The defendant grabbed and ripped the victim's shirt. She then hit the victim approximately eight times in the face with a closed fist and when he attempted to cover his face with his hand's she hit him in the testicles until he was forced to the floor. Once on the floor she attempted to choke him, although at no time did he lose consciousness. The victim and the defendant are boyfriend and girlfriend and have lived at the same residence for approximately two years. The victim identified the defendant as the person that attacked him. The defendant was identified via her FL DL: B612738909670.
