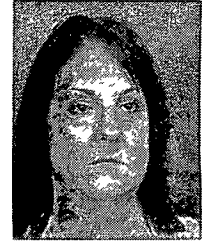

Probable Cause Affidavit

██████████ (4-YEARS-OLD) . ██████████ FURTHER ADVISED HE IS IN THE PROCESS OF DIVORCING FROM HIS WIFE, REBECCA, BECAUSE OF HER DOCUMENTED ISSUES WITH ALCOHOLISM.

ACCORDING TO [REDACTED] AT APPROXIMATELY 1740 HOURS, [REDACTED] WAS ATTEMPTING TO TAKE THE KIDS FOR A WALK WHEN A DRUNK REBECCA RAN OUTSIDE TO INTERVENE BECAUSE SHE DID NOT WANT THEIR KIDS TO WALK WITH [REDACTED] WITHOUT HER. AS REBECCA TRIED TO CONVINCE HER KIDS TO NOT WALK WITH THEIR FATHER, [REDACTED] BEGAN RECORDING REBECCA FROM A DISTANCE FOR DIVORCE PROCEEDINGS PURPOSES. AT THAT TIME, REBECCA WALKED TOWARDS [REDACTED] IN AN AGGRESSIVE MANOR WHILE ATTEMPTING TO GRAB HIS PHONE FROM HIS HANDS. AFTER UNSUCCESSFULLY ATTEMPTING TO RIP THE PHONE OUT OF [REDACTED] HANDS, REBECCA BEGAN GRABBING AND CLAWING [REDACTED] SHOULDER IN FRUSTRATION. [REDACTED] ADVISED REBECCA NOT ONLY MADE CONTACT WITH HIS HAND WHEN SHE TRIED TO TAKE HIS PHONE, BUT SHE INTENTIONALLY PULLED HIS SHIRT AND GRABBED HIS SHOULDER CAUSING HIM BRIEF PAIN AND DISCOMFORT.

██████████ THEN SHOWED ME THE RECORDINGS FROM HIS CELL PHONE. I OBSERVED A WHITE WOMAN, LATER IDENTIFIED AS REBECCA, APPROACHING ██████████ AS HE WALKED BACKWARDS TELLING HER TO STAY AWAY. REBECCA WAS OBSERVED GRABBING ██████████ HAND, ARM, SHIRT, AND SHOULDER IN AN AGGRESSIVE MANOR WHILE BERATING HIM. I COULD ALSO HEAR ██████████ YELLING WHEN HIS SHOULDER WAS GRABBED. THE VIDEO RECORDING WAS UPLOADED INTO EVIDENCE.COM.

NEXT, I SPOKE WITH [REDACTED], WHO PROVIDED THE FOLLOWING STATEMENT: [REDACTED] STATED HIS MOTHER WAS ANGRY WITH HIS FATHER FOR LEAVING THE HOUSE WITH HIM AND HIS SISTER, SO SHE EXITED THE HOUSE AND STARTED THE CONFRONTATION. [REDACTED] ADVISED HE THEN OBSERVED HIS MOTHER APPROACH HIS FATHER AND ATTACKED HIM FOR RECORDING.

FINALLY, CONTACT WAS MADE WITH REBECCA NEAR THE FRONT DOOR WHERE SHE WAS DETAINED AND HANDCUFFED (DOUBLE-LOCK) TO THE BACK. REBECCA WAS READ HER MIRANDA WARNINGS VIA AN AGENCY ISSUED PRE-PRINTED CARD AND WAIVED HER RIGHTS. POST MIRANDA, REBECCA ADMITTED TO GRABBING [REDACTED] AND ATTEMPTING TO REMOVE HIS PHONE OUT OF HIS HAND BUT ADVISED SHE DID SO BECAUSE SHE FELT [REDACTED] WAS PROVOKING HER BY RECORDING.
