Probable Cause Affidavit

Before me this date personally appeared POST, CARLY (10151) who being first duly sworn deposes and says that on 6 day of November, (year) 2021 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33024 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

nine years and have currently resided in the same dwelling with one another in Maryland for the last two years.

Sizemore did intentionally strike [REDACTED] with her right hand to [REDACTED]'s face. Sizemore openhandedly slapped at [REDACTED]'s face a second time, her nails clasp around [REDACTED]'s neck to which [REDACTED] pulled her arm away and Sizemore then fell to the floor. [REDACTED] had visible scratches on the left side of his neck.

Sizemore was then subsequently placed under arrest for domestic battery.

Search incident to arrest of Sizemore's purse revealed a small circular blue plastic container containing within 14 small blue round pills, one side stamped with a capital A and the other side stamped with a 7/6. After speaking with Ronald case # M3682642 of Poison control, it was confirmed that the pills were Adderall, 10 mg, a schedule two class drug.

Sizemore is being charged with domestic battery and possession of a controlled substance without a prescription.

Sizemore was transported to BSO Main Jail.
