PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER: On 6/20/22 at approximately 2136 hours, I was traveling northbound on N Congress Ave approaching the traffic control signal at W Boynton Beach Blvd. I was in my marked BBPD patrol vehicle 4031. On the left turning lane, waiting to turn left from N Congress Ave to travel west on W Boynton Beach Blvd, I observed a black scooter bearing NC tag MA85626. The scooter was being operated by a white male later identified as Rexford Smith. As the left turn traffic control signal turned green and the northbound traffic control signal also turned green, the scooter made an improper turn and lane change. Instead of the scooter turning left (travel westbound), it changed lanes one time to the right and continued northbound on N Congress Ave. The scooter changed lanes while the white road marking (solid white line) was solid (not permitting any changes during that pattern). Based on the scooters action, other vehicles had to press on their brakes to avoid a traffic collision. I then conducted a lawful traffic stop on the said scooter for the said traffic infractions. The scooter came to a stop at the 300 block of N Congress Ave. I made contact with Rexford and advised him of the reason for the stop. Rexford told me that he was on his way to get food and knew that me made an improper turn. I observed Rexford to be unsteady on his feet and his eyes were glossy. I could also smell the strong odor of an unknown alcoholic beverage coming from Rexford's mouth area, which intensified every time he spoke. I asked Rexford if he consumed any alcoholic beverages, which he stated that he did. Rexford told me that he consumed three large cups of Titos and cranberry. Rexford advised that he was coming from a local bar and that he last consumed alcohol beverage was 30 minutes prior to our encounter. I asked Rexford if he could feel the effects of the alcohol and he would me that he could. I then asked Rexford if he had any disabilities, injuries, or issues with his eyes, which he replied no.

I then advised to Rexford that I was conducting a Dui investigation which he understood. I asked him again if he would submit to Standardized Field Sobriety Task's which he stated that he would. I once again asked him about injuries of disabilities and he told me that he did not have any. I still smelled the strong odor of an unknown alcoholic beverage coming from his mouth and his speech was slurred and slow. Rexford was swaying and unsteady on his feet during our encounter.
