Probable Cause

On 7/16/2022 at approximately 2115 hours I, Officer David Morgan of Florida Fish and Wildlife Conservation Commission (FWC), was on water-based patrol around Peanut Island located in Palm Beach County inside of Palm Beach inlet. I observed a vessel towing another vessel southbound inside the IntraCoastal Waterway (ICW) on the south side of Peanut Island. The vessel that was towing, FL 3519 PY, had many occupants onboard and seem to have some trouble towing the other vessel. I initiated a vessel stop to make sure they were ok and conduct a safety check on the vessel.

Upon contact with the vessel operator, later identified Reynier Jesus Brito Gonzalez, FL DL# B632730843440 DOB 09/24/1984, I noticed that Brito Gonzalez had a strong odor of alcohol on his breath with slurred words when he talked during the stop. Brito Gonzalez also had bloodshot, glassy eyes. I conducted a boating safety check and found a child had the improper size personal floatation device (PFD) being worn. I explained to Brito Gonzalez my concerns and clues I was observing from him.

I asked Brito Gonzalez if he would perform Seated Standardized Field Sobriety Tasks (SFSTs) to determine if he was impaired. Brito Gonzalez consented to perform Standardized Field Sobriety Tasks (SFSTs). I had Brito Gonzalez board my vessel to begin Seated SFSTs.

I, as well as family members onboard, translated into Spanish for Brito Gonzalez during the tasks instruction when needed.

I administrated the Horizontal Gaze Nystagmus (HGN), Finger to Nose, Palm Pat and Hand Coordination tasks in that standardized order.

During the HGN task Brito Gonzalez showed clues in both eyes. Lack of smooth pursuit, distinct and sustained nystagmus at max deviation and onset of nystagmus prior to 45-degree. Brito Gonzalez had 6 clues for the task. 4 or more clues indicate impairment.

The next task Brito Gonzalez performed was the Finger to Nose. I started by reading the instructions for the task. Parts of the instructions were read in Spanish so Brito Gonzalez could understand. When told to begin performing the task he had to be reminded to tilt his head back and close his eyes. I re-read the instructions so Brito Gonzalez could understand the task. He confirmed he did. During the performance of the task Brito Gonzalez opened his eyes and did not tilt his head. On the first left he searched, did not use his fingertip (pad of his index finger), missed the tip of his nose (side) and did not bring his hand down. On the first right he did not use his fingertip (pad of his index finger), missed the tip of his nose (side) and did not bring his hand down. On the second left he

did not use his fingertip (pad of his index finger) and did not bring his hand down. On the second right he did not use his fingertip (pad of his index finger), missed the tip of his nose (side) and did not bring his hand down. On third right he used the wrong hand, did not use his fingertip (pad of his index finger), missed the tip of his nose (side) and did not bring his hand down. On the third left he hesitated, did not use his fingertip (pad of his index finger), missed the tip of his nose (side) and did not bring his hand down. Brito Gonzalez had 22 clues for this task. 9 or more clues indicate impairment.

The third task I conducted was the Palm Pat. I explained the task instructions and demonstrated the exercise. I told Brito Gonzalez to begin the task after reading the instructions to him. During the performance of the task Brito Gonzalez showed clues of not counting as instructed (did not count at all), rolled his top hand when turning over, double patted his hands, rotated his top hand so it did not remain parallel and did not increase speed. In total Brito Gonzalez demonstrated 5 total clues on Palm Pat. 2 or more clues would indicate impairment.

The fourth task I conducted was the Hand Coordination I explained the task instructions and demonstrated the exercise. Brito Gonzalez was unable to follow instructions by remaining in the instructed position during the explanation of the task and started at the wrong time. I told Brito Gonzalez to begin after explaining the instructions. On the 1st task (Forward Steps) Brito Gonzalez performed correctly. On the 2nd task (Hand Clapping) Brito Gonzalez did not perform the task (skipped hand clap completely). On the 3rd task (Return steps) Brito Gonzalez performed with improper count (did not count 5-8 during the return step motion). On the 4th task (End position) he did not perform, remaining with his first to his chest until told to lower his hands. In total Brito Gonzalez demonstrated 5 clues on Hand Coordination. 3 or more clues would indicate impairment.

At the conclusion of the SFSTs, Brito Gonzalez was arrested for operating a vessel under the influence at 2135 hours.

I transported Brito Gonzalez to Palm Beach County Main Jail at 2222 hours in my patrol vehicle. At the jail, Brito Gonzalez provided breath samples at 2256 and 2300 hours, respectively. Brito Gonzalez's samples were .184 g/210 L and .189 g/210L, respectively. Brito Gonzalez answered questions, post-Miranda.

F.S 327.35(4) --- Any person who is convicted of a violation of subsection (1) and who has a blood-alcohol level or breath-alcohol level of 0.15 or higher, or any person who is convicted of a violation of subsection (1) and who at the time of the offense was accompanied in the vessel by a person under the age of 18 years, shall be punished:
