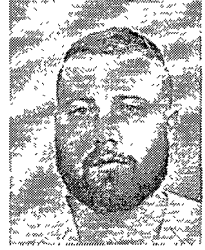

Probable Cause Affidavit

Before me this date personally appeared JENKINS, LARRY (13177) who being first duly sworn deposes and says that on 11 day of September, (year) 2017 at 250 RACQUET CLUB RD 406-3, WESTON, FL 33326 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

and contact was made with hotel security. Deputies were directed to the disturbance / room, and contact was made with the individuals through an open rear window. Bed sheets were observed tied together with additional bed sheets hanging out of the window as if they would be utilized to climb out of the room. Eventually, the occupants were convinced to speak with deputies through the front door of the hotel room.

Contact was established with the individuals in the room through the partially open door. During the contact, the individuals refused to leave the room, and the door was slammed shut. Due to the previous order given by security to leave the property, and the fear that the individuals were going to attempt to climb down the bed sheets, forced entry was immediately made into the room. The door was being braced by all three of the occupants, however they were quickly overpowered by deputies and taken into custody.

Once in custody, the individuals were later identified as, Diahnie Altvater, Owen Miller, and Rhys Comerford. Due to their intentional actions of refusing to leave the property after being advised to do so by hotel staff, intentionally and physically bracing the hotel room door shut in order to prevent law enforcement from entering the room, and intentionally damaging multiple pieces of hotel property within the room, the defendant is charged with Trespassing, Disorderly Conduct, Resist Officer - Obstruct w/o Violence, and Criminal Mischief greater than \$1,000.00
