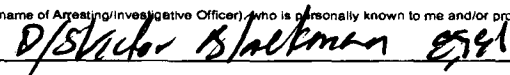

On Sunday June 19, 2022 at approximately 02500 hours, while conducting routine patrol in the area of Lake Worth Road and Congress Avenue, which is located in the city of Palm Springs, Palm Beach County, Florida, I initiated a traffic stop on the defendant's vehicle, a red 2019 Dodge Challenger vehicle bearing FL tag LLYB09, for reasonable suspicion of DUI.											
The defendant was driving eastbound on Lake Worth Rd. and approaching the solid red turn signal at the intersection of Congress Ave. The defendant was slowing the vehicle for the stop light however, he failed to maintain a single lane as he continued approaching the intersection driving over the solid white lane divider. The defendant veered across to the inside turn lane then back centered over the lane divider where the vehicle came to a stop for the red traffic signal. After making a complete stop, the defendant made the left turn to drive northbound on Congress Ave. at a high rate of speed. The defendant continued to fail maintaining a single lane and fluctuating speed from high to slow nearly stopping at solid green light at the intersection of 2nd Ave North. The driver was identified as Ricardo Rivera Alfonso, by their Florida Driver's license. Rivera Alfonso was the sole occupant of the vehicle.											
Upon making contact with the driver, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from his person and face area. This odor intensified as I spoke to Rivera Alfonso. Rivera Alfonso had glassy, glazed, and blood shot eyes. Rivera Alfonso's speech was slurred, slow, thick, and at times difficult to understand. Rivera Alfonso's movements were slow as he struggled to exit the driver's side of the vehicle. Rivera Alfonso was wearing an olive green shirt, black jeans, and black boots. All the clothing appeared somewhat neat in appearance.											
Ricardo Rivera Alfonso showed signs of possible impairment so I requested a traffic unit to conduct an assessment. This affidavit is for supplemental purposes only.

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

Ricardo was observed by Lt A. McDermott I.D. 9724 stopped at the intersection of Lake Worth Rd and Congress Ave in the east bound left turn lanes for a red traffic signal taking up both left turn lanes. Lt A McDermott activated her siren to get Ricardo to move into one lane however instead of moving into one lane he proceeded to make a left turn on a red traffic signal. Lt. A. McDermott began following Ricardo at which time she observed him come to a complete stop at a green traffic signal on Congress Ave north bound at the intersection of Congress Ave and 2nd Ave N. Lt A. McDermott advised that as the vehicle traveled north bound on Congress Ave Ricardo rapidly accelerated to a high rate of speed and had trouble maintaining a single lane.

OBSERVATION OF DRIVER:

Ricardo was observed to have a strong odor of an unknown alcoholic beverage emanating from his head and shoulder area, his speech was slurred and his eyes were blood shot red and watery.

DRIVER'S STATEMENTS:

Ricardo stated that he was coming from a friend home where he had been hanging out, he advised that he was en route to his girlfriends house, when asked how much alcohol he consumed Ricardo did not respond.
