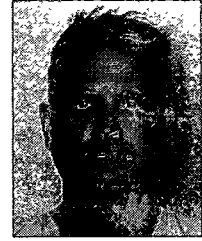

(19028)** who being first duly sworn deposes and says that on **1** day of **December**, (year) **2021** at **777 S FEDERAL HWY, POMPANO BEACH, FL 33062** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On the above date and time, Richard Stubblefield was causing a disturbance at the dock of the Island Club Apartment located at 777 S. Federal Hwy, Pompano Beach, FL., Stubblefield began yelling due to being upset with the presidents of HOA for his apartment complex. After having a couple of alcoholic drinks with his neighbor Marc Kaemper, Stubblefield began to tell him how "he would like to shoot them in the face" referring to Rita Nelson and Dana Fishbein the presidents of HOA. Probable Cause Affidavit

Before me this date personally appeared MORANTES MORENO, JOSE F. (19028) who being first duly sworn deposes and says that on 1 day of December, (year) 2021 at 777 S FEDERAL HWY, POMPANO BEACH, FL 33062 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

After Kaemper notice Stubblefield was carrying a concealed firearm underneath his shirt, he suggested he go put it away in his house due to how intoxicated he was and drawing a lot of attention to himself.

At this time Joseph Norman attempted to speak with Stubblefield to calm him down after overhearing all the statements that he made towards Nelson and Fishbein. Stubblefield then proceeded to grab his handgun and while holding it stated "I really shouldn't have this on me". Stubblefield pulled the handgun out of the holster and proceeded to hold it in plain view of four adults and one 10 year child that were on the scene. Shortly after Stubblefield walked back towards his apartment to secure the handgun.

As I arrived on the scene, Stubblefield was taken into custody and a handgun holster was recovered from his waistband. Let it be noted that Stubblefield was very intoxicated with the smell of alcohol emanating from his person along with slurring his words and had trouble maintaining his balance. Post Miranda as read from a BSO prepared text, admitted to carrying the handgun on his person and that he is not allowed to do so, since he does not have a concealed weapons permit. A record check confirmed Stubblefield has never been issued a concealed weapons permit. Stubblefield gave deputies permission to retrieve the handgun from apartment E105, along with one rifles from his truck.

Stubblefield was charged with the following;

790.01-2 CARRYING CONCEALED WEAPON-FIREARM

790.10 WEAPON OFFENSE-IMPROPER EXHIBIT FIREARM OR DANGEROUS WEAPON.
