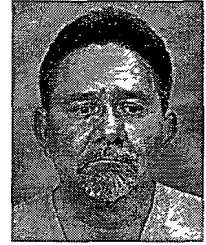

Before me this date personally appeared RODRIGUEZ, ANDREW (15668) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 9702 SW 57TH ST, COOPER CITY, FL 33328 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

To wit I was dispatched to 9702 SW 57th St in reference to a Domestic Disturbance I met with victim, [REDACTED] who stated that she was involved in a physical altercation with her husband, Richard Galvez, over him accusing her of cheating [REDACTED] stated she was sitting on the recliner chair the in the living when Richard became irate and slapped twice with an open hand on her facial area [REDACTED] then put her arms up to block him from hitting her, at which point he began hitting both her arms [REDACTED] stated Richard then stop, and moments later he continued to slap her again and forcibly pulled her arms away from her in two occasions

I observed several bruises on [REDACTED] arms, that were consistent to her statement I took a sworn digital statement and photo's of [REDACTED] injuries

Richard spontaneously uttered that he wanted to go to jail because his wife was cheating on him but denies hitting her

It was determined that Richard was the primary aggressor and he was transported to the Cooper City District office for processing and then to The BSO Mail Jail for booking
