Art.1 § 18(b) On 07/03/22, at approximately 1852 hours, I responded to 6308 Lansdowne Cir in unincorporated Boynton Beach, Palm Beach County, Florida 33472, in reference to criminal mischief. Upon arrival, I made contact with Thomas Fels, who advised on 06/27/22 Monday and 06/29/22 Wednesday, his neighbor Robert McCullough who resides at 6301 Lansdowne Cir, punctured his front and rear passenger-side tires on his red 2020 RAM 1500 bearing F.L. tag (DPLT94). Fels advised it was not until yesterday morning, 07/02/22 he noticed his front and rear passenger side tire was deflated. As a result, Fels advised that he responded to Walmart and purchased two new tires totaling 334.40 dollars. Fels was able to provide CCTV footage of the incident that occurred. Upon reviewing the camera surveillance, a timestamp on 06/27/22 at 2104 hours shows a W/M walking alongside the curb, picking up miscellaneous items on the lawn. Moments later, the same W/M proceeded to the rear tire on the passenger side of the vehicle and crouched down as if he was picking up debris from the lawn however, he quickly punctured the rear tire on the passenger side with an unknown puncture instrument in his right hand, causing the tire to deflate. Fels also provided CCTV footage of the second incident. Upon reviewing the camera surveillance, a timestamp on 06/29/22 at 2106 hours shows the same W/M proceeding toward the aforementioned vehicle and also crouched down as if he was picking up debris from the lawn however he quickly punctured the front passenger side tire with an unknown puncture instrument in his right hand causing it to deflate. I then made contact with McCullough outside of his residence, referencing the above allegations. I read McCullough's Miranda Warning from my department-issued Miranda Warning Card, which McCullough stated he understood. McCullough denied the above allegation however confirmed the W/M subject in both CCTV footage of the incident was indeed him. Based on the information gathered during my investigation, I found probable cause to charge Robert McCullough with Criminal Mischief (\$201-999) pursuant to F.S.S. 806.13(1b2). As a result, McCullough was arrested as I assisted him into the back (prisoner seat) of my PBSO-marked patrol vehicle. McCullough handcuffs to the rear doubled locked and checked for proper fit. McCullough was made aware of his charges. I completed the necessary arrest paperwork and was transported to Palm Beach County Jail.
