The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was driving a black Mercedes SUV (FL Tag #QSUE07) eastbound on Platt St W, and passed me at a high rate of speed. After catching up to the vehicle, I paced it at 50 MPH in a posted 30 MPH zone. This area also had heavy pedestrian traffic due to it being a Friday night and having busy bars/nightclubs nearby. While pacing behind the vehicle, I also observed it drift out of it's lane on the passenger side, crossing over the lane marker and driving in the bicycle lane.

During the traffic stop, the defendant was identified via a PA DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, fumbling fingers, poor balance, he admitted to drinking "a few beers & 2 glasses of wine" prior to driving, and emitted a distinct odor of an alcoholic beverage from his breath.

The defendant was arrested for DUI following a display of 6/6 HGN + VGN and a refusal to participate in additional SFSEs. He was transported to booking without incident.

While at CBT, the defendant was read Implied Consent and refused to take a breath test.
